TO REGISTER COMPLETE THE FOLLOWING:

Traditional 12x12 lots: You must stay within the 12x12 space.

We do not allow booths to stretch into the parking spaces behind rows A and D. All parking behind rows A & D is limited to 24 feet behind your lot. Please do not try to squeeze a larger trailer into this space. We measure the show for optimal safety and maneuverability throughout the show.
